

## **HT 267W Lutheran Ethics**

**Instructor: Craig Nesson**

**Fulfills WTS ethics requirement.**

**Open to all; priority to those fulfilling WTS ethics requirement.**

**3 credits; grade or credit/no credit**

### **DESCRIPTION:**

This course examines the field of Christian ethics, paying attention to distinctively Lutheran themes. Presentations, readings, and case studies examine how Lutheran theology shapes ethical reflection for the church in mission. How do the Word of God, law and gospel, sacraments, liturgy, reason, theology of the cross, Christian freedom, vocation, and two kingdoms teaching inform ethical deliberation? Analysis of ELCA social statements provides the basis for engaging an ethical method. We will consider how to give leadership so that congregations become communities of moral deliberation.

### **OBJECTIVES:**

1. To explain core themes of a Lutheran perspective on Christian ethics (practice of biblical and theological wisdom).
2. To analyze case studies of embodied ethical responsibility (practice of engagement with cross-cultural and global dimensions).
3. To increase capacity to teach ELCA social statements focusing on use in congregations (practice of complex analysis; practice of ecclesial partnership).
4. To form leaders for congregations as communities of moral deliberation (practice of collegiality; practice of immersion in context).

### **PROCEDURE:**

The course will consist of presentations, readings, analysis of ELCA social statements, and case studies.

### **EVALUATION:**

1. Regular attendance.
2. Engagement with assigned readings in student contributions to the course.
3. Leadership in teaching project.
4. Two written assignments— 1) one social statement or message prepared and presented as part of a small group; and 2) summative project: six one-page papers explaining the ethical importance of Lutheran themes.
