Campus Conduct Hotline offers an easy, comfortable way to report activity or behavior you may observe or experience on campus that is harmful, unethical, questionable, or causes you or someone else personal injury. You should call the Campus Conduct Hotline if you experience or observe any of the following:

- Fraud or crime
- Sexual harassment/assault
- Discrimination
- Bullying
- Hazing
- Safety or facility risk issues
- Security and Internet policy abuses
- Code of Conduct violations
- Workplace hostility
- Illegal or unethical business practices
- Any other questionable behavior

## Introducing Campus Conduct Hotline®

### Our Campus-Wide Safety Net

Campus Conduct Hotline is a confidential, independent, call-in service that provides a simple, anonymous\* way for you to help preserve the values and reputation of our institution. One phone call from you can alert the institution administration of problems that may affect the entire campus community.

Protecting and providing

environment for everyone.

### How Does Campus Conduct Hotline Work?

When you call Campus Conduct Hotline you will speak to a friendly, trained specialist who will guide you through the details of your concern. You will be given a case number for your reference, so your call will be completely anonymous.\* It is optional to identify yourself or to provide contact information. Otherwise, no information will be taken about you (the reporter), so you will not be identified.

Your concerns will be submitted to the campus administration for investigation. Using your case number, you can call Campus Conduct Hotline at any time to check on the status of the investigation and learn of any actions that have been taken — thanks to your phone call.

\*Campus Conduct Hotline is a service to receive and report information anonymously. During the institution's investigation process, identifying details may be discovered.
